NOTES & GUIDELINES FOR PROXY SUBMISSION

1. Appointment of Chairman or Designated Representative as Proxy

Members who do not plan to attend the General Meeting in person but wish to vote on the tabled resolutions are requested to appoint the **Chairman of the Meeting** or a **Designated Representative** as their proxy. By appointing a proxy, you ensure your professional voice and vote are counted toward the official quorum and meeting decisions.

2. Requirement for Specific Voting Instructions & General Council Election Rules

You must indicate clearly how you want your votes cast by marking a tick (✓) in the "For", "Against", or "Abstain" column next to Resolutions 1 to 4.

- **Resolution 5 Election Rule:** For Resolution 5 (Election of General Council Members), you may cast a "FOR" vote for a **maximum of four (4) candidates** to fill the 4 vacancies. If you mark "FOR" for more than four (4) candidates, your entire vote for Resolution 5 will be rendered **invalid**.

- **Representation Mechanism:** If you appoint the Chairman with specific voting instructions, the Chairman will cast your pre-marked votes. If you appoint a Designated Representative who attends in person, your pre-marked votes will be officially counted as submitted on your Proxy Form, and your representative will not receive duplicate voting ballots at the scene.

3. Digital Submission of Proxy Forms

To support the environmental initiative of the Institute and reduce paper consumption, please submit your completed and signed Proxy Form electronically using either of the following channels:

4. Strict 48-Hour Submission Deadline

Pursuant to Clause 4.3.11 of the HKIQEP Bye-laws, the completed and signed Proxy Form must be officially received by the Institute no later than 48 hours prior to the meeting time (on or before **18:30 on 16 August 2026 (Sunday)**). Proxy forms received after this designated deadline by any means or submitted by your designated representative in person before the commencement of the AGM will be considered strictly invalid and will not be accepted.

5. In-Person Attendance & Automatic Revocation of Proxy

This Proxy Form will be deemed invalid and revoked if you attend the AGM in person on 18 August 2026. Completion and submission of this Proxy Form will not preclude a Voting Member from attending and voting in person at the AGM on **Tuesday, 18 August 2026** if they so wish. In the event that a member attends the AGM in person, their previously submitted Proxy Form shall automatically be deemed to be revoked and rendered void.

General Council Note on Voting Eligibility

Only Voting Members (Founding Fellows, Fellows, and Professional Members) whose annual subscription fees for the current year are fully settled and who are in good standing are entitled to vote at the General Meeting or appoint a proxy to vote on their behalf.
